

1. All persons entering the ground are only admitted subject to the following Ground Regulations and the Rules and Regulations of the England & Wales Cricket Board and of Somerset County Cricket Club Ltd (hereinafter called "the Club").
2. All persons must comply with instructions and directions issued by Club Officials, Stewards, or Police Officers.
3. All persons entering these premises are entering into a contract with the Club that they will conform to the GROUND REGULATIONS. Please note that these premises are subject to surveillance / filming by CCTV, and/ or BWC.
4. All persons seeking entrance to the Ground acknowledge they may be subject to a search and refusal of said search may result in refusal of entry or ejection from the Ground.
5. The Club reserves the right to eject or cause to be ejected any person who, within the Club confines, is considered by the Club, its employees, or agents, in their absolute discretion to be or have been behaving in a manner likely:
  - To bring the Club or game into disrepute, or
  - To interfere with the comfort, enjoyment, or safety of other spectators, or
  - To impede in any way the activities of the Club, including the progress or conduct of any match, or
  - To be in breach of one or any of these Ground Regulations.
6. Any person evicted will be asked to supply to the Club his or her name and address and the Club shall be entitled to take any steps which they consider necessary, including search of the evicted person, to substantiate the name and address and photographing, for the purpose of enforcing Regulation 17.
7. Play cannot be guaranteed on any day and the Club reserves the right to make changes to its advertised fixtures without notice.
8. Only persons specially authorised by the Club in writing are permitted to offer newspapers, periodicals, or any other articles for sale in the ground.
9. The obstruction of gangways, access ways, emergency exit routes and like places is strictly forbidden.
10. Unnecessary noise or disturbance, such as that from the use of radio sets, mobile telephones, whistles, horns, persistent chanting etc. is not permitted in any Stand and the use of foul, racist or other abusive language and/or conduct including harassment in any form is forbidden in any part of the ground. Offenders may be ejected pursuant to Regulation 5.
11. The climbing of walls, fences, stands, buildings or any other structures in the ground is strictly forbidden.
12. The consumption of alcohol is permitted only in the bars or other authorised places during hours decided by the Club and the right is reserved to close bars at any time and to restrict the consumption of alcohol including the importation of alcoholic beverage into the ground. No alcohol may be brought into the ground on ANY one-day, tourist or International match and searches will take place.
13. The importation of, and / or taking of recreational drugs in any form whilst on the Club premises is strictly forbidden and persons found and/ or assumed to be under the influence will be ejected from the ground pursuant to Regulation 5 and Regulation 17.
14. Bottles, glasses, banners, flags, weapons, or other similar articles (other than those approved by the Club) are not permitted and the Police and the Club Stewards shall have the right to confiscate any such articles, which at their absolute discretion they may consider could be a danger or insulting to other spectators. The throwing or discharging of missiles is strictly forbidden.
15. Members' are expected to adopt reasonable standards of dress and behaviour in all Members' enclosures. "Reasonable Standards" are self-evident and common sense, but as

a guide, torn clothing such as jeans, shorts, shirts are unacceptable. So too are "T" shirts with offensive slogans thereon. Singlet's, bare feet, and bare torsos are unacceptable in food and bar areas and when moving around the ground. On hot days, Members may remove their shirts when sat in their seat but should this cause offence to people sitting in the vicinity, Members are requested to cover up or move. Failure to comply will lead to ejection from the ground.

16. The designated "Family and Non-Alcohol Stands" have specific requirements for all matches: the stands are available for families, children, elderly and those wishing to sit in an alcohol-free area and therefore alcohol may not be consumed at any time; those using the stands must respect its aims and behave in an acceptable manner – they must not wear any item of clothing that has an offensive message or slogan and bare torsos are not permitted at any time. Failure to comply with these requirements will lead to ejection from the stands in accordance with Regulation 5.
17. The Club may, in its absolute discretion, bar from entry to the ground, for any period, any person prosecuted or ejected in accordance with Regulation 5 and may take steps, including informing the parents or guardians of the person concerned of the said bar, as they consider necessary or desirable for the implementation of the said bar.
18. Any person barred from the Club under Regulation 5 shall not enter or attempt to enter the premises during the currency of the said bar, and any person found on Club property during the currency of such a bar may be proceeded against by the Club in the County Court for damages for trespass and/or injunction.
19. Dogs will only be allowed to enter the Club property under the strict control of their owner for County Championship and One-Day matches. Should they cause any damage or inconvenience, this permission may be withdrawn at any time. Dogs (other than assistance or medical, limited to one per spectator) will not be allowed to enter the Club property during T20 and International matches or major events days. Dogs must not be left unattended within the ground or within parked vehicles on Club property in accordance with the Animal Welfare Act 2006.
20. No vehicles other than emergency vehicles shall be parked in any part of the ground other than in designated parking bays. The Club reserves the right at its absolute discretion to remove any vehicle parked in contravention of this Regulation and shall not be liable for any damage thus caused.
21. All vehicles are parked entirely at their owner's risk and adhere to the 5mph speed limit. Parking is not guaranteed and subject to availability on each match day. At the close of play or in during an evacuation, cars will be held in the Ground for a minimum of 15 minutes to allow spectators on foot to leave the Ground.
22. Spectators shall not deface or obscure any notice or advertisement within the Club grounds or immediately outside.
23. As required by Law, smoking and or vaping is prohibited in all areas of the ground except for the "Designated Smoking Areas".
24. Children under the age of 14 must not be left unaccompanied in any part of the ground.
25. In relation to the cricket match taking place at the ground spectators are not permitted to use a mobile telephone, tablet, laptop, computer, or other kind of communication device to either (i) communicate or in any way transmit any form of commentary, data or other material, for any kind of betting or corrupt or unlawful purpose; or (ii) conduct continuous betting trading activity.
26. The Club reserves the right at its absolute discretion to alter these Ground Regulations from time to time. Such alterations shall be announced in the manner the Club considers most appropriate.
